- 1 Before completing this Form of Proxy, please also read the sections entitled "Action to be Taken" set out in the Scheme Document. Save where otherwise defined herein, capitalised terms and expressions used in this Form of Proxy shall have the meanings given to them in the scheme document of the Company dated 10 December 2025 (the "Scheme Document").
- 2 Only Scheme Shareholders, or their duly appointed representatives, are entitled to attend and vote at the Court Meeting. A member entitled to vote may appoint one or more proxies, who need not be members, to exercise all or any of his/her rights to attend and vote on his/her behalf.
- 3 The Form of Proxy gives your proxy(ies) full rights to attend and vote. If you appoint a proxy other than the Chairman of the Court Meeting, you must ensure they attend in person in order for them to represent you at the Court Meeting.
